Re: Dearness Relief payable to STAFF PENSIONERS i. e. Pension to Ex-Employees of Bank of Baroda for the months from August-2024 to January-2025

In terms of Regulation 37 of Bank of Baroda (Employees') Pension Regulations, 1995 Dearness Relief is payable to pensioners in accordance with the rates specified in Appendix II of the said Regulations .The confirmed All India Average Consumer Price Index numbers for industrial workers for the quarter ended June-2024 are as follows:
