- 2. The cars will be sold to H-1 bidder who has submitted the highest offer for the vehicle. If the highest quoting party fails to honor the bid, the contract will be cancelled & its EMD forfeited. In such an event, an opportunity shall be given to the next highest quoting eligible tenderer (H-2 quoting party) to complete the bid provided it is prepared to accept the price offered by H-1 party. (If H-2 fails then will offer H-3 followed by H-4 etc subject to match H-1 Price.). In case of any dispute, decision of Dy. General Manager (C&A) of Zonal office shall be final.
- 3. Offers accompanied by cheques in lieu of Demand Draft/Bankers' cheques will not be valid.
- 4. Earnest money deposit will be forfeited if successful bidder fails to deposit balance amount of offered price within 12 days from the date of communication by Bank or intends to withdraw the offer subscribed to its acceptance by the Bank.
- 5. Bank reserves the right not to dispose of the vehicle and/or to reject any or all of the offers without assigning any reason for such action what so ever.
- 6. The offers should reach us on or before 15.00hrs on 17-12-2024.
- 7. The bids shall be opened on 17-12-2024 at 15.30 Hrs. The bidder or their authorized representative (not more than one) may witness the Tender Opening, at the time of opening the quotations.
- 8. The offers which do not fulfil all the conditions will not be considered.
- 9. On acceptance of offer, the delivery of the cars will be given to Offer or only after Demand Draft/Banker's Cheque and Sale Documents deposited by the offer or for the full payment is realized.
- 10. The delivery of Cars will be given from our office within 15 days from the date of realization of DD/Bankers Cheque for the balance Amount of offered price and Registration car of Tender only not allowed any Third party registration etc.
- 11. All the cost and expenses in connection with the transfer of Registration with RTO will be borne by the purchaser.
