4. The tenders shall be opened on **31.01.2025 3.15 PM** at the above referred address in the presence of the representatives of the bidders. No separate intimation shall be sent to the bidders for their presence at the time of opening of tender. Only one representative shall be allowed to remain present during the opening of the tender.
5. The vehicle will be available for examination/inspection at Jamkhambhaliya from 11.01.2025 to 31.01.2025 between 11.00 a.m. to 4.00 p.m. on working days with prior appointment. 6. The floor price (reserved price) of Car is Rs. 50,000/- (Rupees Fifty Thousands Only). The vehicle will be sold to H-1 bidder who has submitted the highest offer (more than the set reserved price) for the Vehicle. However final decision will be taken by the Bank in this regard.
7. Earnest money deposit (EMD) will be forfeited if successful bidder fails to deposit balance amount of offered price within -07- days from the date of communication by Bank or intends to withdraw the offer subsequent to its acceptance by the Bank.
