- The bid should be accompanied by Earnest Money Deposit of Rs 10,000/-(Rupees Ten Thousand Rupees Only) by way of a crossed Demand Draft in favour of "Bank of Baroda", Payable at Gandhinagar.
- 3. Bank of Baroda, IT Deptt. NSSC has evaluated the minimum reserved price for each items as mentioned below-
