Financial Bid (FB) should contain strictly financial details, viz: rate per sq. ft. of carpet area, details of Municipal taxes and lease expenses etc. Municipal taxes will have to be borne by the landlord. Carpet area shall be internal finished wall to wall area measurements only (as per IS code 3861-2002) excluding Verandah, Corridor & passage Entrance hall & Porches, Staircase & stair cover, Shaft & machine room for lift, A/C Ducts/ plant room, Shaft for sanitary / water-supply / garbage/ firefighting / electricity / telecommunication /AC, Bathrooms, Lavatories, Stilt, Covered / open parking spaces, Pump Room, Flower Bed, Watchmen / s Chowky, Storage Tanks, Chajja, Canopies & Worship Places
