- 5. Bank shall not accept any offer below reserve price. Bids shall be treated as rejected, If Quoted amount for above mentioned old car/s are lower than reserve price
- 6. Please submit your quote in two separate envelope one for technical bid which will contain bidder's KYC document, forwarding letter & DD of EMD price. If any document is missing the tender will be rejected. 2<sup>nd</sup> envelope will contain only the price offered. The price bid will be opened only for technically selected bidder.
- 7. Earnest Money shall be returned to unsuccessful bidders after accepting the offer by highest quoted bidder within 15 days without payment of interest thereon.
- 8. The purchaser has to bear the expenses towards transfer of the vehicle in his/her name with R.T.O, subsequent insurance premium, local taxes etc.
- 9. On acceptance of offer by the Bank, the purchaser has to deposit the full amount within -07- days of the receipt of intimation from the Bank, otherwise the deposited amount towards earnest money will be forfeited and the submitted offer will be treated as cancelled.
