Tender Notice

Sub:- Disposal of old/obsolete computer hardware and peripherals

Sealed quotations are invited for the disposal of obsolete computer hardware and peripherals (CPU, Monitor, Keyboard, Mouse and Printer) on an "As Is Where Is Basis". The Tender Document can be downloaded from the website of Bank of Baroda i.e. www.bankofbaroda.com under link "Tender". Important dates of tender related activities are as under: -

General Terms and Conditions:-

- The bidder must be registered as a Recycler/Reprocessor of eWaste with Central Pollution Control Board, Ministry of Environment and Forests, Government of India or with the State Pollution Control Board or State Governments dealing with E-waste etc. Bids received from the firms other than so registered will be summarily rejected.
- The bid should be accompanied by **Earnest Money Deposit of Rs 5,000/- (Rupees Five Thousand Rupees Only)** by way of a crossed **Demand Draft** in favour of "Bank of Baroda", Payable at **Gandhinagar**.
- The details of the hardware and its quantity is mentioned as below-

- The bidder must provide the price for each peripheral (CPU, Monitor, Keyboard, Mouse, and Printer) to decide the per unit price for each.
- The successful bidder will have to pay the entire quoted/offered amount in the form of Bank Draft drawn in favour of "Bank of Baroda" payable at Gandhinagar within **five working days** after receipt of letter regarding award of contract, failing which the contract may be cancelled and the EMD will be forfeited.
- All items are to be sold on an "As Is Where Is Basis". No warranties, express or implied, regarding the condition of the items will be provided.
- The bidder shall be required to quote for all items (CPU, Monitor, Keyboard, Mouse and Printer). In case the bidder has not offered their rates for any item listed in, the bid shall be treated as incomplete and summarily rejected.
- Each page of the tender document should be signed by the bidder(s). Incomplete and unsigned quotations are liable to be rejected.

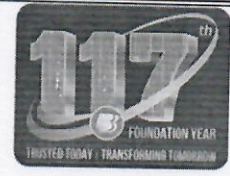


- The Bid shall be legible, typed/printed and be in Hindi/English only. All the pages of the Bid should be serially numbered and signed.
- The envelope shall also indicate the name, address and phone number of the Bidder enabling the Bid to be returned, if required.
- The bidder must not be blacklisted by any Department of the Government of India or of any State/or by any PSU/Autonomous Organisation of Government. An Undertaking regarding non-blacklisting of the bidder by any Government Organization must be furnished by the bidder in the tender document in the format given in Annexure A. Bids without above undertaking will not be considered.
- Any Overwriting /Crossing in the Figure shall not be considered for acceptance of the rates offered by the bidder. Incomplete and unsigned Quotation are liable to be rejected.
- No bidder will be allowed to withdraw after submission of bids/opening of the tender; otherwise the EMD submitted by the firm would be forfeited.
- This tender is non transferable.
- H-1 will be determined on the basis of total amount quoted of the items listed in Annexure 'C'.
- **The Green Disposal Certificate, measured in metric tons, must be submitted by the successful bidder within 15 days from the date of transportation of e-waste from GIFT City, Gandhinagar. The EMD shall be released upon receiving the Green Disposal Certificate.**
- The successful bidder shall remove the old/obsolete computer hardware and peripherals within 7 working days of award of the contract.
