The Assistant General Manager, Bank of Baroda, Karnal Region, invites sealed Re-Tenders from Electric Auditors/approved licensed contractors/firms/agency from Bureau of Energy Efficiency (BEE) (Govt. India) to carry out Electrical Audit of branches (including onsite ATM premises) and offices in the Haryana numbering approximately 44 plus branches (including onsite ATM premises) /offices as per Audit Performa given in the Tender Format.

The interested vendors fulfilling the following conditions may apply in two Bid System (Technical Bid and Financial Bid):

- 1. The engineer/agency carrying out the Electrical Audit must be a accredited energy auditor from BEE (Bureau of Energy Efficiency)
- 2. Agency/ individual must have valid GSTIN number.
- 3. Agency/ individual must have PAN No.
- 4. Agency/individual must be an Income Tax Assesses for the last three years. Agency/ individual must have minimum turnover of Rs.33,000/- per annum for last three years.
- 5. The Agency/individual preferably at least 5 years of experience of carrying out electrical safety audit
- **6.** The Agency/individual should have satisfactorily completed one similar job worth minimum 80% i.e., of **Rs.88,000/-** during last five financial years.

OR

The firm should have satisfactorily completed two similar jobs, each worth minimum 50% i.e., Rs.55,000/- during last five financial years

**OR** 

The firm should have satisfactorily completed a three similar jobs, each worth minimum 40% i.e., of **Rs.44,000/-**(value) during last five financial years.

Applicant shall submit the performance Certificate from the respective previous employers in support of above otherwise application is liable to be rejected





- 7. Agency/firm must have turnover of Rs.33000/- per annum each for the last three years
- 8. Similar job/s shall means Electric audit work executed in Government/Private/Public Sector Undertakings/Reputed firm.
- 9. Individual/Agency preferably have own office/local contact person in Haryana State or Adjoining Areas. The firm preferably has its own office/local contact person functioning in Haryana state or Adjoining Areas for not less than three years as on the date of commencement of issue of Application Forms.
- 10. Duly filled & signed application /offers shall be submitted in two bid system in the following manner:

# Instructions to the Applicants for furnishing information as a part application for pre-qualification

- 1. Intending Applicants are required to submit their applications with full bio-data giving details about their organization, experience, technical personnel in their organization, competence and adequate evidence of their financial standing, etc. in the enclosed form which will be kept confidential.
- 2. While deciding upon the pre-qualifications of Electric Auditor, great emphasis will be given on the ability and competence of applicants to do good quality works within the specified time schedule and in close co-ordination with other agencies.
- 3. Decision of the Bank in regard to selection of Electric Auditor will be final and binding on the applicants. The Bank is not bound to assign any reason for acceptance / rejection of any applications.
- 4. <u>Each page of the application shall be signed.</u> The application shall be signed by persons / persons on behalf of the organization having necessary authorization / Power of Attorney to do so.
- 5. If the space in the Performa is insufficient for furnishing full details, such information may be supplemented on separate sheets of paper, stating therein the part of the Performa and serial number. Separate sheets shall be used for each part. However the format shall be as per Performa.

## 6. **SPLITTING OF ORDER**

The Bank reserves its right for splitting scope of work between two service providers. The splitting of the order will be in 60:40 ratios, provided the L2 service provider agrees to match the rates quoted by L1 service provider and agrees for all the terms and conditions. In case L2 service provider is not willing to match L1 rates, Bank will call L3, L4 service providers etc., in that order to step into the shoes of L2 service provider. In the event of L3, L4 etc., service provider not matching the L1 rates the entire quantity will be awarded to L1.

A copy of the report duly signed by the licensed Electrical Auditor/ Engineer on behalf of the firm is to be submitted to respective Branch and Regional Office.
- 12. The rates quoted shall be binding for Twenty Four months from the date of awarding of the contract and no increase whatsoever will be considered. In the event of any breach of contract, the Security Amount (EMD) will be forfeited
- 13. Electrical Audit of all the branches (including onsite ATM site premises)/offices must be completed **within 45 days** from the date of awarding the contract in case of single contractor/agency selected for 44 branches/office. If all branches/office electrical audit work is split between two individual/agency, then completion period for complete the allotted audit of branches/office will be 20 days for each agency.

### 19 PERFORMANCE BANK GUARANTEE

- A) Successful bidder should produce an unconditional Performance Bank Guarantee from a Scheduled Bank (other than Bank of Baroda) equal to 10% of the total cost of the project and effective for the period of 2 years from the date of work order. During the period of contract
- 20. The actual quantity of branches/offices to be audited may vary from the projected quantity as per the requirements of the Bank.
- 21. Any delay in completion of the work over the stipulated period will attract penalty of 1% of the contract value per day subject to maximum of 10% of the contract value.
- 22. Earnest Money Deposit of Rs.3000/-, in the form of a demand draft/pay order issued by a scheduled commercial bank favoring Bank of Baroda, payable at Karnal must be submitted along with the Technical Offer. Offers not accompanied with Earnest Money Deposit of will not be accepted. This amount will be forfeited if, having been selected by the Bank for the job, the bidder refuses to accept work order or having accepted the work order, fails to carry out his obligations mentioned therein.
