FORMAT OF AGREEMENT TO BE SIGNED

This Agreement is made on between Bank of Baroda, a body corporate under
Banking companies Acquision and Transfer of Undertaking Act 1970 and having its
Head Office at Mandvi, Baroda, and one of its Office Service Branch, Jaipur herein after
referred to Bank which expression shall unless excluded by or repugnant to the context.
Thereof include its successors and assigns of the one part and M/s(
Name of Agency) through its Manager(
Address) having its business / office at above address.
Herein after called as Agency / Courier which expression shall include its successors
and assigns on the other part.
WHEREAS, the above Agency / Couriers are carrying on the business of collection, carrying and delivery of documents from place to place in Jaipur and nearby BOB Branches of Jaipur Distt., in accordance with the instructions of their clients.
WHEREAS, the bank is interested in getting transported its documents expeditiously from one place to another place, and at specified offices/ Branches of the Bank,
WHEREAS, the time is the essence of the contract and any delay may jeopardize the interest of the Bank.
WHEREAS, the Courier has undertaken to do the above job to the satisfaction of the Bank.
NOW, IT IS HEREBY AGREED, by and between the Parties, as follows:
1. That, the arrangement under this agreement for Courier Service is beingmade for three year effective fromhowever, the renewal of the agreement will depend on handling of satisfactory services, by Agency and also as per discretion of Bank. Further, Bank has discretion to terminate the agreement at any time, without any notice, pre-informing and without assigning any reason, whatsoever.
 That, the Agency shall collect, carry and deliver to specified offices/branches, existing as well as future on the routes, specified by Bank, clearing instruments, cheque, drafts, dividend/Interest warrants, draft advices, bills, letters, daketc, loose or sealed envelope or locked bag, in the same condition as given by Bank. That, the Services of Collection of Cheques& its delivery at Service Branch,

Jaipur will be available to the Bank, on all days of week, except on Second &

Fourth Saturday / Sundays and Bank Holidays.

- 4. That, since time is the essence of agreement the Agency / Courier will observe punctually of time and will adhere strictly to the time schedule laid down from time to time by Bank for the time being Courier shall adhere to the given time schedule.
- 5. That, the courier at its own risk and responsibility will carry the packet/locked bags through their accredited representative by motor Bike/scooter to specified offices on the route designated by Bank, as per Annexure 'A', in the same condition as given by an office/Branch by the Bank. Time being the essence of contract, in case the Agency/ Courier fails to deliver the packet/bag within the stipulated time, they would be under obligation to explain to the Bank, the reasons for the same to the satisfaction of the bank and the Bank may forfeit 2 days remuneration and charges, penalty to the amount spent or might have been spent for alternate arrangements.
- That, the Agency / Courier will obtain the acknowledgement from the addresses/branches of the Bank and if so required by Bank shall provide proof of such acknowledgement for having delivered the packet/bag at the designated Centers.
- 7. That, the Agency / Courier will ensure absolute security, safety, secrecy and confidentiality of documents, instruments while giving its services and will arrange the packets/bags to be delivered in the same condition duly closed, sealed or locked as given by an office/branch of the Bank.
- 8. That, the Agency / Courier hereby undertake to indemnify the Bank, against any loss, damage, and expenses as the Bank may be put to or incurred by the Bank. However, due to delay, non performance of this contract by non-delivery, loss, stolen, misplaced or damages to any packets or bags or documents whatsoever.
- 9. That, the Bank will make claim if any in writing within 30 days from the date of loss, shortage, damage or non delivery of consignment/documents.
- 10. That, the Bank will pay charges as per the schedule below for the services rendered by the Courier bill for that will be submitted to Bank on monthly basis up to 5th of succeeding month.
